Peter.

Thank you for the invitation to these two events. Unfortunately current project commitments will prevent my attendance. While I have no particular comments on the Australian approach to setting AAQ standards, I present the following comments with respect to the queries and discussion raised in the AAQ NEPM Review (pages 141-142):

- New health evidence to support a revised standard?
  - Noting the apparent lack of threshold for adverse effects, there would appear to be evidence to warrant consideration of revised standards for many pollutants. Further consideration to NO2 and SO2 standards to ensure they are suitably protective of potential short-term peak exposures would seem appropriate given recent data.
- Is the current approach of allowable exceedences of the standard suitably protective, or are there [better] alternative methods?
  - Support is given to a zero exceedences approach based on health protection and requiring reporting of the cause of exceedences, progress towards meeting the standards, and actions taken in conjunction with provisions for 'natural' or 'exceptional' events. The following reasons are given:
    - § A zero exceedence approach is readily understood *prima facie* by all stakeholders. Reporting of causes of exceedences etc. provides transparency of process.
    - More than the allowable exceedences of the NEPM standard may result from 'natural' or 'exceptional' events in a given airshed. Currenty, when assessing risks to public health these events must already be identified and suitably discussed, and allowances typically made during further evaluation. Inclusion of provisions for 'natural' or 'exceptional' events in the NEPM would in many respects simply be formalising existing process, but with greater transparency and accountability.
    - § A zero exceedence approach, as discussed by the review paper, is inherently more conservative. This should allow for the setting of air quality standards with higher concentrations or longer averaging times, which are thus typically less demanding of air quality monitoring requirements, while offering the same level of public health protection.
- Should changes be made to the reporting protocols that would lead to greater transparency and better understanding of causes, potential risks, and management approach?
  - Ideally, yes. Realistically, government as a whole does not retain the expertise and is unlikely to commit the resources for meaningful and timely assessment to occur. In this context, any measures to reduce or

simplify reporting, allowing for more prompt use of data as required, are likely to be of greater net benefit.
